and the Ventura County Federation of College Teachers AFT Local 1828, AFL-CIO.

Public Content

Issue

This item presents for approval the March 26, 2015, Tentative Agreements between the Ventura County Community College District (VCCCD) and the Ventura County Federation of College Teachers AFT Local 1828, AFL-CIO (AFT) reached in re-opener negotiations.

Background/Analysis

VCCCD and AFT representatives commenced contract re-opener negotiations for Fiscal year 2014/2015 in September 2014. On March 26, 2015, the parties signed Tentative Agreements on Articles 4 (Health and Welfare Benefits) and 3 (Salary). AFT membership voted to ratify the Tentative Agreements on April 30, 2015.

The Tentative Agreements (attached) provide as follows:

- No change to Article 4 Health and Welfare Benefits.
- Article 3 Salary: Add to Article 3.1.D:
 - The full-time faculty salary schedule will be adjusted upwards by 1.22% and the part-time faculty salary schedules will be adjusted upwards by 2.44% for a total overall increase of 1.7% effective 7/1/14, and no later than May 31, 2015, affected members will receive a retroactive salary payment reflecting the adjustment.
 - No later than July 31, 2015, all full and part-time salary schedules shall be adjusted effective July 1, 2015, to reflect actual 2014/15 FTES growth as reported on the Form 320 in July 2015, based on the attached proration chart, Attachment A.

Fiscal Impact

\$1,102,000 - Use of General Fund Unallocated Reserves for a retroactive faculty salary schedule

adjustment, with a potential salary schedule adjustment in FY16 if the District does not achieve growth target; and

\$476,000 – Use of General Fund Unallocated Reserves for a retroactive classified salary schedule adjustment, with a potential salary schedule adjustment in FY16 if the District does not achieve growth target.
