## PERSONNEL COMMISSION MEETING MINUTES FOR MARCH 15, 2012

FOUR HUNDRED AND FORTY-FOUR The four hundred and forty fourth meeting of the Personnel Commission of the Ventura County Community College District was held on Thursday, March 15, 2012, at 6:00 p.m.

### 1. CALL TO ORDER

Commissioner Harison called the meeting to order at 6:02 p.m.

### 2. ROLL CALL

In attendance were Commissioners David Gonzales, Barbara Harison, and James King. Michael Arnoldus, Director of Employment Services/Personnel Commission and Secretary to the Personnel Commission, was also present.

### 4. MINUTES

On motion by Commissioner Gonzales and seconded by Commissioner King, the minutes of the Tuesday, February 21, 2012 meeting of the Personnel Commission were unanimously approved.

Mr. Arnoldus indicated a letter requesting a disciplinary appeal hearing was received on February 21, 2012. The item is on the agenda for closed session.

Director Arnoldus discussed the regular meeting of Tuesday, March 13, 2012. He discussed the presentation provided by Sue Johnson, Vice Chancellor of Business and Administrative Services, regarding the budget. Mr. Arnoldus also indicated that there were public comments regarding the closure of the college cafeterias and the corresponding impact to District personnel. A brief discussion ensued regarding the closure of the cafeterias.

C. Director's Report

Director Arnoldus reviewed the monthly *Current Recruitments Report* that included six open recruitments and two closed recruitments. The *Positions Filled and Pending Report* reflected three

positions filled and three pending selection. Commissioner King inquired about the report header "Number of Applicants," and asked if the number consists of those that pass or all who have applied. Director Arnoldus replied that it is everyone who has applied and noted that the number may increase for those positions that have a status of open. Commissioner Harison noted that the status for Community College Police Officer I is reopened. A discussion ensued regarding the difficulties associated with recruiting police officers and if there is any relationship to compensation.

#### 8. RECLASSIFICATION OF POSITIONS

<u>Reclassification of an Instructional Lab Technician II – Learning Resources (VCU463) position</u> <u>occupied by Cynthia Hulce in the Learning Resources Center at Ventura College</u>

Matthew Escobedo, Human Resources Analyst II, stated that a request came from management to study various positions in the Learning Resources Center at Ventura College. Based on the information collected during the course of the study, HR staff determined that the subject position was not classified appropriately. Mr. Escobedo stated that the primary distinguishing characteristics between an Instructional Lab Technician I – Learning Resources and an Instructional Lab Technician II – Learning Resources is the responsibility for installing software packages in a networked environment and performing advanced troubleshooting for both software and hardware. He said that Ms. Hulce is not assigned or performing either of these functions. Consequently, the position should be reclassified to Instructional Lab Technician I – Learning Resources.

A discussion ensued between the Commissioners and Mr. Arnoldus regarding the impetus of the study, organizational structures at the other colleges, and the length of time during which the employee was working out-of-class.

On motion by Commissioner Gonzales and seconded by Commissioner King, the reclassification of the Instructional Lab Technician II – Learning Resources position occupied by Cynthia Hulce to the classification of Instructional Lab Technician I – Learning Resources was unanimously approved.

Daugherty; if he is not available, Mr. Joseph J. Woodford; if none of these individuals are available, then Mr. Arnoldus will bring this item back to the Personnel Commission. All Commissioners voted in favor of the motion.
