# A. Classified Employees Representative's Report

Maria Urenda, SEIU Chief Steward, reported that Michael Haberberger, SEIU Director, and she meet with Vice Chancellor Shanahan and Director Arnoldus to discuss the classified salary study. Chief Steward Urenda indicated that they were pleased with the direction the study was headed.

### B. Board of Trustees Meeting Report

Director Arnoldus stated that as a reminder, the employee in the Student Outreach Specialist study is on leave and is not expected to be back until January at which time they will start the study. Director Arnoldus also stated that the Office Assistant position would start soon, but the current level of selection workload is the highest priority.
