

# OEI Federal Financial Aid Consortium Agreement Student Request

The OEI Exchange Federal Financial Aid Consortium Agreement is entered into between the Home College, and the Teaching College named below. The Home College, may be able to provide federal financial aid funds based on combined units from both colleges and upon determination of eligibility for the term in which the student is participating in the Course Exchange. This completed form must be on file with your Home College before units can be added into your aid calculation for the term.

## Student Responsibilities:

- Students must be enrolled in at least one course at the Home College in the current term.
- Students must have a completed FAFSA on file with the Home College.
- All courses registered for through the Course Exchange are included in the Student Education Plan on file at the Home College.
- Students must submit a completed Consortium Agreement Request Form to the Home College Financial Aid Office.
- Students are responsible for any fees owed to the Teaching College. Check the Teaching College website for deadlines associated with payment of fees.

I agree to send to my Home College official transcripts from the Teaching College at the end of the term if I fail to do so, my future Financial Aid may be in jeopardy.

I agree that per Federal regulation 34 CFR 668.34, I must meet my Home College's Satisfactory Academic Progress requirements (***visit Home College website for SAP policy***)

I understand that by submitting this request, I am not guaranteed approval of Federal Financial Aid funds based on the combining of units from both the Home and Teaching Colleges.

I have read and understand the OEI Exchange Federal Financial Aid Consortium Agreement instructions and understand my obligations. I understand that failure to meet any part of this agreement may result in having to repay funds received based on this agreement.
