### Approval of Minutes:

It was moved by Ms. Sue Johnson, seconded by Dr. Robin Calote and carried on a unanimous vote to approve the minutes from the Santa Paula Redevelopment/Ventura County Community College Joint Powers Improvement Authority meeting on November 4, 2009.

# Financial Status of Authority Trust Fund

VCCCD provided a 2009-10 financial status of Authority Trust Funds through May 20, 2010 (FY 2009-10), including a reconciliation of pass-through receipts. Ms. Johnson explained the year-to-date expenditures and noted that there is a projected ending balance of \$269,725. This amount will be available for the 2010-11 fiscal year.

It was moved by Ms. Sue Johnson, seconded by Dr. Gabino Aguirre, and carried on a unanimous vote to approve the Financial Status of Authority Trust Fund for fiscal year 2009-10 (through May 20, 2010).

These figures will be audited through the VCCCD's general audit which will take place in August.

# • Approval of FY2010-11 Budget

Ms. Johnson reviewed the proposed budget for Fiscal Year 2010-11. The projected beginning balance will be \$269,724 with an estimated \$70,000 in revenue for a total 2010-11 budget of \$339,725. The projected budget includes an expenditure for the total lease amount for the facility on Dean Drive in Santa Paula, which is \$209,892.

There was a brief discussion about other possible facility locations in Santa Paula, specifically the former John Jenkins Christian Academy facility located on 10<sup>th</sup> Street, which is vacant. Dr. Calote explained there are some ADA access compliance issues. The City of Santa Paula offered to commit resources/staff to assess the structure for the feasibility of adding an elevator.

It was moved by Dr. Robin Calote, seconded by Ms. Sue Johnson, and carried on a unanimous vote to approve for Fiscal Year 2010-11 Budget.

The meeting was adjourned at 3:23 p.m. by Dr. Larry Miller.

Next meeting is tentatively scheduled for Wednesday, November 3, 2010 at 1:30 p.m. It is proposed that this meeting be conducted via teleconference.
