CONFERENCE WITH LEGAL COUNSEL regarding ANTICIPATED LITIGATION under Government Code Section 54956.9(b), the Board will consider only six cases. Specifically, the existing facts and circumstances that might result in litigation against VCCCD arise from the following:

- Raymond Centeno, a former District police officer, has threatened litigation against VCCCD based on the conditions of his employment. Copies of the letter dated October 14, 2002 from Mr. Centeno's attorney have been made available through the office of Pat Kistler, and Ms. Kistler has additional copies with her this evening for distribution to the public upon request.
- 2. Timothy Suel, a counselor at Ventura College, filed a Tort Claim against VCCCD on July 11, 2002, which the Board denied on August 22, 2002. Mr. Suel has not yet filed a lawsuit against VCCCD. Copies of the Tort Claim have been made available through the office of Pat Kistler, and Ms. Kistler has additional copies with her this evening for distribution to the public upon request.
- 3. Marian Carrasco, a counselor at Ventura College, filed a Tort Claim against VCCCD on July 23, 2002, which the Board denied on August 22, 2002. Ms. Carrasco has not yet filed a lawsuit against VCCCD. Copies of the Tort Claim have been made available through the office of Pat Kistler, and Ms. Kistler has additional copies with her this evening for distribution to the public upon request.
- 4. Laura Hilton, a classified employee at Ventura College, filed a Tort Claim against VCCCD on November 12, 2002, which the Board denied on November 26, 2002. Ms. Hilton has not yet filed a lawsuit against VCCCD. Copies of the Tort Claim have been made available through the office of Pat Kistler, and Ms. Kistler has additional copies with her this evening for distribution to the public upon request.
- 5. Beatriz Herrera, a counselor at Ventura College, filed a Complaint of Discrimination against VCCCD on September 17, 2002 with the California Department of Fair Employment and Housing which issued a Right-to-Sue Notice on September 19, 2002. Ms. Herrera has not yet filed a lawsuit against VCCCD. Copies of the Right-to-Sue Notice are available from Pat Kistler.
- 6. Golden Tee, Inc. filed a Claim against VCCCD on December 20, 2002. Copies of the Claim are available from Pat Kistler.

Trustee Gonzales pointed out that there were six cases to be discussed in Closed Session instead of seven, as indicated on the agenda.

At 7:00 p.m. President Hernández announced that the meeting would be delayed. President Hernández reconvened the meeting in Open Session at 8:00 p.m. in the Campus Center

Conference Room. He apologized for the delay.

CLOSED SESSION REPORT

President Hernández read the following Closed Session Report:

In the case of *Gerald Leavitt and Gerard Kapuscik vs. VCCCD*, the Ventura County Community College Districtwide Foundation, Philip Westin, Robert Gonzales, Arturo Hernández, Allan Jacobs, and Norman Nagel (Ventura County Superior Court Case No. CIV212979), on December 10, 2002, the Board voted unanimously to approve an agreement whereby the Plaintiffs, Mr. Leavitt and Mr. Kapuscik, on behalf of themselves and on behalf of all taxpayers of Ventura County, agreed to dismiss the lawsuit in exchange for a promise by VCCCD and the other Defendants not to bring any future action against the Plaintiffs. The Settlement Agreement has now been signed by all parties and the case has been dismissed in its entirety. Copies of the Settlement Agreement are available from Pat Kistler. Additionally, copies of the investigative report prepared for the law firm of Liebert Cassidy Whitmore are now available from Pat Kistler.

In the case of *AFT and Paula Muñoz vs. VCCCD* (Public Employment Relations Board Case No. LACE4170), on December 12, 2001, the AFT withdrew the Unfair Practice Charge, and on December 20, 2002, the Public Employment Relations Board dismissed the Complaint against VCCCD and closed the case.

In the case of *Valerius Lindsey vs. Oxnard College* (Los Angeles County Superior Court Case No. BC279207), the Board unanimously voted to respond to the Complaint.

In the case of *Wood & Bender, LLP vs. VCCCD* (Ventura County Superior Court Case No. CIV216408), the Board unanimously voted to respond to the Complaint.

Regarding the threatened litigation against VCCCD by former District police officer Raymond Centeno, the Board unanimously voted to approve a Settlement Agreement whereby VCCCD will pay to Mr. Centeno the sum of \$350,000 in exchange for mutual releases. Copies of the Settlement Agreement are available from Pat Kistler.

3. **Position Announcement and Composition of the Chancellor's Search Committee (5.5)** was moved by Trustee Rooney, seconded by Trustee Jacobs, and carried on a unanimous vote, to approve the position announcement and composition of the Chancellor's Search Committee. (McRoberts – absent)

Trustees Rooney and Jacobs gave a brief report on the December 20th and January 9th Chancellor's Search subcommittee meetings. It was pointed out that the student trustee was added to the list of subcommittee members, along with an additional community member from each trustee area. There was a brief discussion regarding this item. It was decided that a short job description would be sent to the Board for the community members. The subcommittee asked each Board member to provide two names of individuals to serve on the Chancellor's Search Committee prior to the next Board meeting.

Brandy Huffer addressed the Board regarding the selection of the community members for the Chancellor's Search Committee.

Request for Proposals Executive Search Firms** (**5.6**) was amended to include the following changes, with a motion from Trustee Rooney, seconded by Trustee Jacobs, and carried on a unanimous vote, to approve the Request for Proposals from Executive Search firms to provide consulting services to the Board of Trustees in their recruitment of a Chancellor for the District. (McRoberts absent)

 - Break out Services and Request a Cost Per Item
 - Send out RFP globally

The subcommittee will bring a list of candidates to be interviewed to the next Board meeting.

Business Services

- 5. Adoption of 2003-2004 Nonresident Tuition rate, Foreign Student Capital Outlay Surcharge, and Foreign Application Processing Fee (6.8.2) was moved by Trustee Jacobs, seconded by Trustee Gonzales, and carried on a 3-2, with President Hernández, Trustees Gonzales and Jacobs voting yes, and Trustees Heitmann and Rooney voting no, to adopt the 2003-2004 Nonresident Tuition rate, Foreign Student Capital Outlay Surcharge, and Foreign Application Processing Fee as follows: (McRoberts absent)
 - a. A foreign student capital outlay surcharge rate, effective Summer 2003, of \$14 per semester unit,
 - b. A foreign student application processing fee, effective Summer 2003, in the amount of \$50 per applicant,
 - b. A nonresident tuition rate, effective Summer 2003, of \$149 per semester unit (the Statewide average cost rate, an increase of \$8 per unit and an increase in revenue estimated at \$108,000).

Lydia Ledesma-Reese, Larry Calderon, and Eva Conrad commented on the rate increase. Trustee Rooney expressed her concerns about the District's loss of revenue.
