#### MINUTES FOR THE SPECIAL MEETING OF APRIL 23, 2003

The Special Meeting of the Board of Trustees of the Ventura County Community College District was held on Wednesday, April 23, 2003, in the Cowan Conference Center, Camarillo, California.

#### CALL TO ORDER

President Hernández called the meeting to order in the Cowan Conference Center, Ventura Room, at 4:11 p.m.

RECESS TO CLOSED SESSION

At 4:30 p.m. the Board recessed to Closed Session to consider the following items:

- Beatriz Herrera, a counselor at Ventura College, filed a Complaint of Discrimination against the District on September 17, 2002, with the California Department of Fair Employment and Housing which issued a Right-to-Sue Notice on September 19, 2002. #### PUBLIC COMMENTS REGARDING CLOSED SESSION AGENDA ITEMS

Candace Peyton, Charlotte Wakenhut, Penny Hahn, Michelle Orozco, and Angelica Gonzales addressed the Board regarding the elimination and reduction of classified positions.

At 7:38 p.m. Chancellor Walker announced that the Board would be in Closed Session for an additional 30 minutes.

#### PLEDGE TO THE FLAG

Tom Kimberling led the pledge to the flag.

#### CLOSED SESSION REPORT

In the case of *Paula Muñoz vs. VCCCD*, Ventura County Superior Court Case No. CIV206043, on February 28, 2003, the Board voted 4-1, with Trustees Hernández, Heitmann, Rooney, and Jacobs voting "yes," and Trustee Gonzales voting "no," to approve a Settlement Agreement. The Agreement now has been fully executed and is final. The Agreements provides, in part, for the District to pay to Ms. Muñoz the sum of \$62,500. Copies of the Agreement are available from Pat Kistler.

In the matter regarding Beatriz Herrera, on February 28, 2003, the Board voted 4-1, with Trustees Hernández, Heitmann, Rooney, and Jacobs voting "yes," and Trustee Gonzales voting "no," to approve a Settlement Agreement. The Agreement now has been fully executed and is final. The Agreement provides, in part, for the District to pay to Ms. Herrera the sum of \$10,000. Copies of the Agreement are available from Pat Kistler.

Regarding the Claim filed by Donetta Corbett on March 25, 2003, the Board voted unanimously to deny the Claim.

#### ITEMS FOR DISCUSSION

#### Projections for 2003-2004 Budget Michael Gregoryk gave a brief summary of the 2003-04 proposed budget methodology.

Trustee Rooney asked for a fully executed SIG contract and suggested that the Board review alternative methods of saving money in the contract. There was a brief discussion regarding this item.

Rabin Polito addressed the Board regarding SIG and IBM contracts. The Board asked Mr. Polito to put his concerns in writing.

George Hajj, President of MAT2000, addressed the Board regarding the request to re-bid the district-wide computer bid on the agenda.

## **Ceremonial Resolutions**

1. Resolution to Honor Retiring Ventura County Community College District Administrator, Ruth Hemming (1.1) was moved by Trustee Jacobs, seconded by Trustee Heitmann, and carried on an unanimous vote, to honor Dr. Ruth Hemming for her service to the Ventura County Community College District. Trustee Rooney read the resolution.

### Human Resources

2. Elimination and Reduction of Classified Positions (5.3) was moved by Trustee Gonzales, seconded by Trustee Jacobs, and carried on a unanimous vote, to approve the elimination and reduction of particular classified positions throughout the District as listed. (McRoberts – no)

Chancellor Walker gave a brief overview of the item. The Board asked for an update at the May 13<sup>th</sup> Board meeting.

**3. Approval of VCCCD-AFT Side Letter of Agreement (5.4)** was moved by Trustee Gonzales, seconded by Trustee Rooney, and carried on a unanimous vote, to approve a Side Letter of Agreement between the Ventura County Community College District and American Federation of College Teachers, AFT Local 1828, to address the faculty proportionate share of the District's 2003-2004 deficit. (McRoberts – yes)

The Board acknowledged the negotiating team for their efforts in addressing the faculty proportionate share of the deficit.

### **Business Services**

- 4. Methodology for Allocating Fiscal Year 2003-04 Resources (6.8.1) was moved by Trustee Rooney, seconded by Trustee Heitmann, and carried on a unanimous vote, to approve the methodology for allocating fiscal year 2003-04 resources as recommended by the Budget Allocation Review Committee Task Force. (McRoberts – yes)
- 5. Request for Adoption of a Preliminary Level of Reserves for fiscal year 2003-04 (6.8.2) was moved by Trustee Gonzales, seconded by Student Trustee McRoberts, and carried on a unanimous vote, to establish a preliminary level of reserves of 3% for fiscal year 2003-04. (McRoberts – yes)
- 6. Request to Re-bid the District-Wide Computer Bid (6.8.3) was moved by Trustee Rooney, seconded by Trustee Gonzales, and carried on a unanimous vote, to re-bid the District-Wide computer bid. (McRoberts – yes)

Trustee Rooney recommended that at the 6-month renewal period that the item not be renewed because at the time of bid the item was not in good standing with the State of California.

Sue Johnson and Terry Cobos gave a brief explanation of this item. Rabin Polito commented on this item.

Chris Valenzano addressed the Board on behalf of Assemblyman Tony Strickland regarding student fee increase.

There was a brief discussion and it was decided that the ad hoc committee would recommend 3-5 applicants to the Board for interview. Trustee Gonzales indicated that he would like to review the applications. The Board recessed to Closed Session at 10:00 p.m. The Board reconvened in Open Session at 12:29 a.m. and announced that a Special Board meeting was scheduled for May 6 at 6 p.m. in the District Service Center conference room.
