ARTICLE 1 PREAMBLE

It is the purpose of this Memorandum of Understanding (hereinafter referred to as Agreement) to designate operational responsibility between the Ventura County Community College District Police Department (hereinafter referred to as VCCCD Police Department) and the City of Ventura Police Department (hereinafter referred to as VPD). This Agreement is made and entered into this <u>29</u> day of <u>January</u>, 2024, between the VCCCD Police Department and VPD.

This Agreement supersedes any prior agreements between the involved parties.

ARTICLE 2 AUTHORITY

- 2.1 This memorandum is the statement of agreement reached by the VCCCD Police Department and VPD, in compliance with Assembly Bill 913 which enacted California Education Code Section 67381, which is also known as the Kristin Smart Campus Safety Act of 1998. This legislation requires the VCCCD Police Department to enter into a written agreement with VPD designating which law enforcement agency has operational responsibility for the investigation of Part 1 violent crimes, sexual assaults, and hate crimes. It further requires that the specific geographical boundaries of each department be identified for operational responsibilities.
- 2.2 Section 72330(a) of the California Education Code further advises that the governing board of a community college district may establish a community college police department under the supervision of a community college chief of police, and may employ personnel as necessary to enforce the law on or near the campus of the community college and in or about other grounds or properties owned, operated, controlled, or administered by the community college, or by the state acting on behalf of the community college.

ARTICLE 3 BACKGROUND

3.1. VPD provides municipal law enforcement services for the City of Ventura, State of California. The VCCCD's Ventura College is located within the incorporated area of the City of Ventura. The VCCCD has its own District-wide Police Department, certified by the California Commission on Peace Officer Standards and Training, which provides law enforcement services to Moorpark, Oxnard, and Ventura Community Colleges.

ARTICLE 4 ADMINISTRATIVE AND TERM

- 4.1 The VPD Chief of Police and the VCCCD Police Department Chief of Police, or their designees, will serve as the primary representative of each department in all contacts between the two departments and with regard to any revisions to or deviation from this Agreement.
- 4.2 A copy of this Agreement shall be made available for public viewing in accordance with Section 67381(e) of the California Education Code.
- 4.3 This Agreement shall continue in force until such time either party requests revision or termination. Either party may terminate this Agreement by giving the other party ninety (90) days of written notice of the party's intention to terminate. Any plans for revision shall be submitted to the other party in writing. In accordance with Section 67381(e) of the California Education Code, this Agreement shall be reviewed and updated, if necessary, every five years after July 01, 2016.

ARTICLE 5 OPERATIONAL RESPONSIBILITIES

- 5.1 The investigation of all crimes occurring on the Ventura College campus property will be the responsibility of the VCCCD Police Department's Ventura College Station, with the following exceptions, which will be the responsibility of VPD:
 - a.) Homicide / Manslaughter
 - b.) Forcible Rape
 - c.) Kidnapping
 - d.) Serious Bodily Injury / Fatal Traffic Collisions
 - e.) Officer-Involved Shooting
 - f.) Investigations Requiring Specialty Units
- 5.2 VPD will be notified immediately by the Ventura College Station of any and all of the above-listed crimes, and will assume primary responsibility for the investigation and provide the lead investigator(s). The Ventura College Station will provide assistance as required and follow the investigation with VPD.
- 5.3 VPD will provide investigative aid for crimes of sexual assault and hate crimes occurring within the jurisdictional boundaries of the Ventura College Station, in accordance with California Education Code Section 67381.

- 5.4 VPD will be the primary investigating agency for all death investigations, including deaths related to overdose, suicide, and natural causes. The Ventura College Station will provide assistance as required and follow the investigation with VPD.
- 5.5 Both VPD and Ventura College Station will respond to any request for assistance made by the other agency in accordance with their respective policies.
- Incidents involving missing persons from the Ventura College campus will be reported to VPD without delay for follow-up investigation pursuant to California Penal Code Section 14211. If the preliminary investigation indicates suspicious activity or foul play, VPD will be notified immediately to allow for rapid response and the full use of its resources.
- 5.7 The Ventura College Station will enforce the California Vehicle Code and other traffic regulations on the college campus. College police officers may enforce the California Vehicle Code and other traffic regulations on streets adjacent to and in the immediate vicinity of the campus should the violation warrant enforcement action. Parking enforcement on streets adjacent to the campus will be primarily the responsibility of VPD.
- 5.8 The Ventura College Station will assist VPD in any mutual aid request, be it with personnel or the use of college facilities.
- 5.9 VPD will assist the Ventura College Station in any mutual aid request, in particular with regard to incidents of civil disturbance or major unrest.
- 5.10 The Ventura College Station will be responsible for all police services at special and sporting events held on college property.
- 5.11 If special events held on the Ventura College campus require the assistance of VPD, VPD will enter into an agreement with the special events sponsors for recovery of costs for those services, not unlike that between the special events sponsors and the Ventura College Station.
- 5.12 VCCCD police officers are authorized by law to investigate crimes that have occurred within their jurisdiction anywhere in the State of California. If the Ventura College Station investigates a crime beyond a one-mile radius of the college, it will notify the proper jurisdiction as a courtesy. VPD will assist the VCCCD police officers as much as possible with investigations extending into the City of Ventura when requested to do so by VCCCD police officers.
- 5.13 VPD officers attempting to serve an arrest or search warrant on the Ventura College campus will notify the Ventura College Station and request their assistance. VCCCD police officers will notify VPD when officers attempt to serve a warrant within the jurisdiction of VPD.

5.14 To assist in coordinating activities between the Ventura College Station and VPD, VPD officers, whether in uniform or in plainclothes, going onto the college campus to take law enforcement action will notify the Ventura College Station located on the northeast corner of the college near the intersection of Loma Vista Road and Day Road (contact: 805-289-6486).

ARTICLE 6 JURISDICTIONAL BOUNDARIES

6.1 Pursuant to Section 72330 of the California Education Code and Index Letter Opinion No. 92-809,¹ the primary jurisdiction of the VCCCD Police Department officers is "on or near" the college district properties. Areas or locations that are "near" the college district properties are defined as sidewalks and streets bordering the college campus property, as well as nearby businesses which are primarily patronized by students, professors, and staff. This may include the area near the college, public or private, from which an officer standing on the college premises could observe a public offense that might be committed against college personnel, students, or college property. The extent of such areas and locations, including the "immediate vicinity" of the college premises, shall be determined on an individual basis, based upon the nature and seriousness of the public offense. Typical off-campus VCCCD police patrol should not extend beyond more than one mile from the campus boundaries.

The geographical boundaries of Ventura College, located at 4667 Telegraph Road, Ventura, consist of Telegraph Road to the south, the east alley of North Ashwood Avenue to the west, Loma Vista Road to the north, and Day Road to the east (Appendix A).

- 6.2 VCCCD police officers may affect arrests and issue citations for violations of the California Vehicle Code when such violations do not occur on VCCCD property, but do occur on city or county streets that are on or near the college property.
- 6.3 VCCCD police officers shall restrict their field patrol activities to the college campus and to the areas "on or near" and in the "immediate vicinity" of the college properties, with the following exceptions:
 - a.) Requests for assistance from public safety agencies (i.e., local police, fire, and paramedics) to locations that are not "on or near" college properties;
 - b.) Emergency life threatening situations (e.g., "officer needs help" broadcasts, citizen "flag downs") even though they are not "on or near" college property;


- c.) Misdemeanor and felony crimes in progress that are not "on or near" college property but which are observed by VCCCD police officers, provided there is immediate danger to a person or property, or to prevent the escape of the perpetrator of the offense.
- 6.4 If a VPD officer or a VCCCD officer witnesses a violent crime that is within the defined jurisdiction of the other agency, the officer will take immediate action to: (1) terminate the crime and apprehend the suspect, if possible; (2) immediately notify the other agency and request assistance; and (3) subsequently provide appropriate documentation of involvement to the investigating agency as soon as possible.
- 6.5 VPD shall be responsible for the response to, and investigation of, all crimes occurring on all property and roadways adjacent to, but apart from, the Ventura College campus. This area extends away from the curb of each roadway or street. Those crimes occurring within the curbside and on the sidewalk extending towards the campus will be the responsibility of the Ventura College Station, except for the crimes listed in Section 5.1.

ARTICLE 7 AGREEMENT SIGNATORIES
